## PET AGREEMENT

This agreement applies to companion pets other than Service Animals.

**I hereby agree to the following regulations and conditions while staying at Hotel Capstone with my pet:**

- I agree to pay a nonrefundable fee for my pet of \$ 65 plus tax per pet. I understand that additional fees may apply in the event my pet causes any damage.
- I agree to keep my pet on a leash or in a carrier while in public areas.
- I agree to refrain from allowing my pet to enter in any food & beverage areas including pool areas, event space and on-site restaurant.
- I agree to be present while any member of the Hotel staff such as housekeeping or maintenance, is in the room. Room cleaning must be scheduled in advance for a time when the pet is not in the room or when the owner is present.
- I agree to keep my pet with me or a designated individual at all times and not to not leave him/her unattended in the room.
- I agree to prevent noise or any other disturbance by my pet, in the interest of other Hotel guests.
- I agree to pay any additional cleaning bills or repairs should they be required and authorize the Hotel to charge my credit card for such charges, even if the said damages are discovered following my departure from the Hotel.
- I agree that, should my pet create any disturbances, which cause complaints to be made to the Hotel by other occupants or personnel of the Hotel, at the request of the Hotel manager, I shall immediately make arrangements to house my pet elsewhere outside of the Hotel.

In consideration of the Hotel and/or Jackson Hospitality Services, Inc., permitting me to house my pet(s) at the Hotel for the duration of my stay, I and my successors and assigns, release and discharge the Hotel and Jackson Hospitality Services, Inc., together with its past or present officers, directors, employees, agents, attorneys, insurers, affiliated companies, successors and assigns from all actions, suits, debts, bills, contracts, controversies, agreements, promised, trespasses, damages, judgments, claims and demands whatsoever, in law or equity, known and unknown, which I or my successors or assigns ever had, now have or hereafter can, shall or may have, and including, but not limited to, any claims relating in any way to my stay at the Hotel relating to the presence of my animal(s) on or about the Hotel's premises against or relating to the Hotel and/or Jackson Hospitality Services, Inc.
